HOUSING ASSIGNMENTS: Summer housing applications must be returned by Monday May 5th, 2014. The Office of Residence Life will assign housing locations in the next 1-2 business days. If your application is incomplete, you will be placed at the bottom of the priority list. All signatures must be secured by the housing deadline. Applicants must have been a residential student the previous term and registered for the Fall 2014 semester. **No graduates or students working off-campus will be allowed to live on campus during the summer break unless they receive approval from the Director of Residence Life.** A written petition must be attached to this application for consideration. Any student who has been on **Social Probation**, has been **suspended** by MVNU, or has special medical needs must be approved by the Director of Residence Life for summer housing.

All summer residents will be housed in Birch Apartments. Students will be housed by gender in groups of six. Housing will be based on the above priorities on a first-come, first-serve basis. Apartments in Birch will not be opened for student use unless each occupied apartment is at capacity. **Birch Apartments will not be available for summer housing before May 20th or after August 18th. All summer residents must be available to move to or from summer residency on those days (if they are needing housing the days before May 20th and after August 18th).**

Pioneer College Caterers will NOT provide FOOD SERVICE during the summer. Meals can be purchased at a la carte prices when the cafeteria is open to accommodate other groups on campus. MEDICAL ASSISTANCE is NOT provided during summer breaks. Any student with medical needs must interview with the University Nurse, and the Director of Residence Life before the application can be accepted.

NOTE: First weeks room charge is DUE IN ADVANCE, payable to Student Accounts (**\$61.00 per week or \$16/night**). The first payment is due when this form is signed by Student Accounts. It is mandatory that students keep their account current through weekly payments to Student Accounts in order to maintain campus housing. Room payment will not be added to student's account. If the student's room bill is not paid in a timely manner, the delinquent student will be required to move out of summer housing.

A STUDENT WHO LEAVES RESIDENTIAL HOUSING FOR ANY PERIOD OF TIME (2-3 days, 1 week, 2 weeks, etc.) will continue to be charged as long as belongings remain in the room. When moving out of campus housing, students must checkout with a Summer RA, return apartment key and sign checkout forms. Students will continue to be charged if they do not properly check-out with a summer RA.
